to amend articles

(No)

I

The name of this corporation is ROYAL CANYON PROPERTY OWNERS ASSOCIATION.

II

The purposes for which this corporation is formed are as follows:

(a) The specific and primary purpose is to investigate and attempt

to effect action on matters including Master Plans, Traffic Patterns, Zone Changes, Variances, City Ordinances, Recreational Facilities, and other factors bearing upon the development of the Hill areas and other adjacent areas thereto, with the object of assuring an orderly and proper development in the best interests of all the citizens of the area, while preserving the integrity of our native resources and their natural beauty.

(b) The general purposes and powers of the corporation are as follows:

(1) To associate this corporation with other land owners associations to carry out the specific purposes of this corporation.

(2) Those purposes and powers which are provided by law and which are necessary, incidental to and in furtherance of the specific and principal purpose of the corporation, and, in addition thereto, to engage in all lawful activities and operations usually and normally engaged in by property owners groups.

III

No part of such income or such principal shall be contributed to any organization whose net earnings, or any part thereof, inure to the benefit of any private shareholder or individual, or any substantial part of the activities of which is carrying on propaganda, or otherwise attempting to influence legislation.

2 The corporation is one which does not contemplate pecuniary gain  
3 or profit to the members thereof and it is organized solely for nonprofit  
4 purposes. Upon the winding up and dissolution of this corporation, after  
5 paying or adequately providing for the debts and obligations of the corporation,  
6 the remaining assets shall be distributed to a nonprofit fund, foundation or  
7 corporation, which is organized and operated exclusively for charitable,  
8 educational, religious and/or scientific purposes which has established its  
9 tax-exempt status under applicable federal and state laws. If this corporation  
10 holds any assets in trust, such assets shall be disposed of in such manner as  
11 may be directed by decree of the superior court of the county in which this  
12 corporation's principal office is located, upon petition therefor by the  
13 Attorney General or by any person concerned in the liquidation.

15 This corporation is organized pursuant to the General Non-Profit  
16 Corporation Law.

17 VI

18 The corporation shall not issue capital stock. The incorporators  
19 and members shall not be liable for the debts of the corporation.

20 VII

21 The principal offices of the corporation are to be located in the County  
22 of Los Angeles, State of California.

23 VIII

24 The number of directors of the corporation shall be not less than five  
25 (5) and not more than thirteen (13). The names and addresses of the persons
